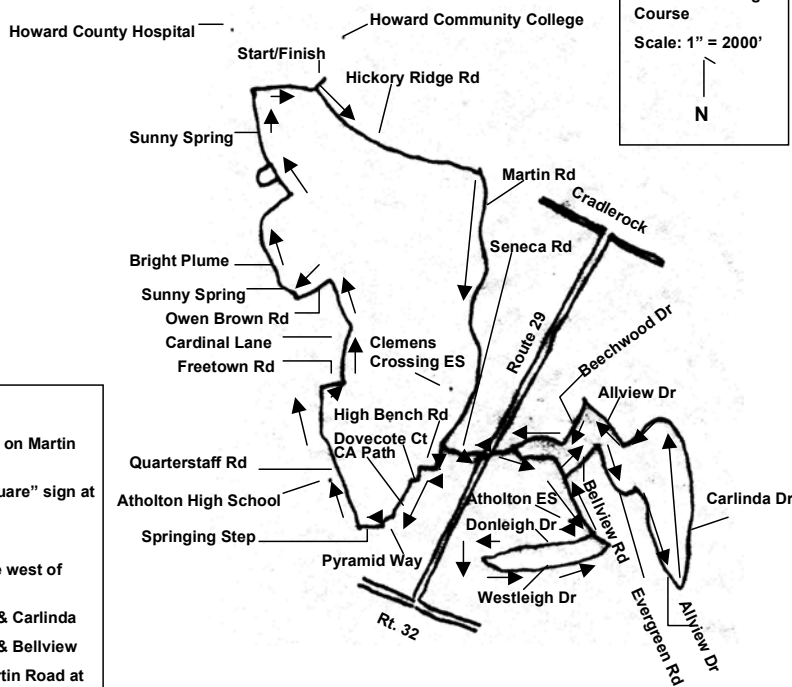


**Course Notes:**

- Martin to Hickory Ridge – with traffic, crossing Windsor Ct. at cone before crossing turning onto Seneca to cross Rt 29 on south side of bridge;
- Turning onto Owen Brown – course runs against traffic;
- Cardinal to Sunny Spring – runners lane coned entire stretch;
- Sunny Spring – run against traffic to HCC;
- Coned sections – Hickory Ridge Rd and Owen Brown Road

**Mile Markers:**

- 1M – just past calming circle on Martin Road # 6232
- 2M – Just past “Clemens Square” sign at Shady Grove Road
- 3M – 10126 Donleigh Drive
- 4M – Bridge on Seneca Drive west of Atholton ES
- 5M – Intersection of Allview & Carlinda
- 6M – Intersection of Allview & Bellview
- 7M – High Bench just off Martin Road at Fortnight Ct & Oxhorn Ct
- 8M – Quarterstaff and Freetown Road
- 9M – Sunny Spring at Plaited Reed & Resting Sea
- 10M – HCC side entrance at “No Outlet” sign

**Water Stops:**

- Atholton Elementary School (Approximately miles 2.75 and 3.75)
- Dovecote Ct at CA path (Approximately mile 7.25)

Start: Hickory Ridge Road in between Bridlerain & Charter at Storm Drain  
 Right on Martin Road  
 Left on Seneca Drive (after crossing Windsor Ct), crossing Rt. 29 on Exit 17 Bridge  
 Continue on Seneca past Atholton ES  
 Right on Donleigh Drive  
 Left on Westleigh Drive  
 Left on Seneca Drive  
 Right on Bellview Drive  
 Right on Evergreen Avenue  
 Right on Allview Drive (no sign for Allview Drive at this point)  
 Left on Carlinda  
 Right on Allview  
 Left on Beechwood Drive  
 Right on Seneca Drive (crossing Rt. 29 again)  
 Left on Martin Road  
 Right on High Bench  
 Left on Dovecote Ct  
 Right after 1/10 mile  
 Right on path between 6645 Dovecote and the mailboxes to path about 2/10 mile through the trees – bear right at blue “open space” sign  
 Enter Pyramid Way cul de sac with #6729 on left  
 Right on Springing Step  
 Right on Freetown Road  
 Right on Quarterstaff Rd  
 Left on Cardinal Lane  
 Left on Owen Brown Road  
 Right on Sunny Spring  
 Left on Bright Plume  
 Left on Sunny Spring  
 Right on Hickory Ridge Rd to finish at HCC side entrance at yellow “No Outlet” sign
